### Which course is for you?

- For general personal skills in resolution .....Course 1
- To help others in their peace making; as friend, pastor, counsellor ..... Course 1 & 2
- To be able to mediate resolution between other individuals or groups .... Course 1 & 2 & 3

### Course 1 "Peacemaker" Biblical Conflict Resolution

Learn the biblical framework for resolving conflict. What does Matthew 18 really mean? What does Matthew 18 look like when it is practiced? Going privately, taking another, taking it to the church (what does that mean?) ..... don't take your fellow believer to court. Confession and forgiveness? How do you open that kind of conversation? . This training will establish and explain proven principles and good practices that can be applied in all conflict situations in a way that honours God.

### Course 2 Coaching & Negotiation for Conflict Resolution

It is not your conflict but someone you know has a conflict situation. They ask for your help. This course will give you the skills to coach them through the process of negotiating and reconciling their conflict. Learn the stages of a resolution process, manage the resolution environment, know the process options available in helping others reach resolution more easily. Is there an actual negotiation going on here? Of course there is, and we will help you become aware of these negotiation dynamics.

### Course 3 Mediating & Arbitrating for Conflict Resolution

You have been asked to be present to help two parties to find resolution in their conflict. There are proven processes to mediate good outcomes. This course will teach, rehearse and role play the mediation processes using real cases.
